#### Protocol of visual material use

Use visual material on website / Social Media



- The copyright with regard to the content of the website is vested in ESTTV TAVERES. It is not permitted to publish the content of the website in whole or in part and / or to reproduce it in any form or in any way without prior permission from the board of the association.
- During all activities organized by the association, photo and video recordings may be made by members and / or caretakers of members.
- For recordings that are intended or used for publication on our own website prior permission is not requested from data subjects, nor are they informed of this;
- No pictures of individual children are placed on the website of ESTTV TAVERES.
- Surnames are only placed if the person(s) hold a position at ESTTV TAVERES, such as members of the board and supervisors and trainers. If the person in question does not agree with this, the last name will be deleted.
- No addresses and telephone numbers are mentioned other than from those with a function for ESTTV TAVERES, such as members of the board, supervisors and trainers.

# Provision to third parties

We can provide the data that you give to us to third parties when this is necessary for carrying out the above described purposes.

For example, we use a third party for:

- Providing the internet environment of the AVG program;
- Events to a named company;
- Keeping track of the members list via Sportaal as part of SSC;
- Communication to members and participants in tournaments via WhatsApp and Versio;
- Using cloud services of all data via Dropbox.

We never pass on personal data to other parties with whom we have not entered into a processor agreement with. With these parties (processors), we make the necessary arrangements to ensure the security of your personal data. Furthermore, we will not pass on the information provided by you to other parties, unless this is legally required and permitted. An example of this is that the police request us (personal) data in the context of an investigation. In such a case we must cooperate and are therefore obliged to provide this information. We may also share personal data with third parties if you give us permission in writing.

#### Within the EU

We do not provide personal data to parties which are located outside the EU.

#### **Minors**

We only process personal data of minors (persons under 16 years of age) if written permission has been given by the parent, caregiver or legal representative.

## Storage period

ESTTV TAVERES does not store personal data longer than necessary for the purpose for which it was provided or required by law.

## **Security**

We have taken appropriate technical and organizational measures to protect your personal data against unlawful processing, for example we have taken the following measures;

- All persons who can take note of your data on behalf of ESTTV TAVERES are obliged to maintain their confidentiality.
- We use a username and password policy on all our systems;
- We use pseudonyms and ensure the encryption of personal data if there is reason to do so:

- We make back-ups of the personal data in order to be able to recover these in case of physical or technical incidents;
- We regularly test and evaluate our measures;
- Our employees have been informed about the importance of the protection of personal data.



## Rights concerning your data

You have the right to inspect, rectify or delete the personal data we have received from you. You can also object to the processing of your personal data (or a part thereof) by us or by one of our processors. You also have the right to have the data provided by you transferred by us to yourself or by order of you directly to another party. We can ask you to identify yourself before we can comply with the aforementioned requests.

When you have given us permission to process your personal data, you will always have the right to withdraw this consent.

## **Complaints**

If you have a complaint about the processing of your personal data, we ask you to contact us directly. We will try to find a solution together. You always have the right to file a complaint with the Dutch Data Protection Authority, this is the supervisory authority in the field of privacy protection.
